FIRST AMENDMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR HART LAKE HILLS

THIS FIRST AMENDMENT to Declaration of Covenants and Restrictions is made this 2nd day of November, 1998, by BEL CAPITAL, INC., a Florida corporation (hereinafter the "Developer").

WHEREAS, the Developer recorded a Declaration of Covenants and Restrictions for HART LAKE HILLS SUBDIVISION on February 20, 1998, in Official Records Book 3978, Page 955, Public Records of Polk County, Florida (hereinafter the "Declaration");

WHEREAS, the Developer is the owner of the substantial majority of the lots within HART LAKE HILLS SUBDIVISION and wishes to amend the Declaration pursuant to Article XIV, Paragraph B thereof.

NOW, THEREFORE, Developer hereby amends the Declaration as follows:

- 1. Article XII, Paragraph J of the Declaration is amended to read as follows:
- J. Wheeled vehicles of any kind, boats, recreational vehicles or any other offensive objects may not be parked or kept on any part of a Lot forward of the house, except that private automobiles and pick-up trucks without commercial signs may be parked in the driveway. Visitors for periods of less than twelve (12) hours are excluded. Boats, recreational vehicles, trailers, motor homes, camping trailers, and all commercial vehicles must be completely housed within the closed garage.
- 2. Article XIV, Paragraph B of the Declaration is amended by adding the following sentence at the end of paragraph, to-wit:
 - *Any amendment of this declaration which would affect the surface water management system, including the water management portions of the common areas, must have the prior written approval of the Southwest Florida Management District."
